- II. Celebrating What God Has Done Tyler Kelley, Executive Pastor
  - The average worship attendance in quarter three, for the last three years, has been: 2021-803; 2022-770; and 2023-826.

  - An update was given about our "Fill the Floor" challenge, a part of the "For the Future" campaign. The bottom floor has been filled, and we have already received 100 chairs over our original goal. As such, we are continuing the challenge and going to begin filling the balcony.

needed: \$12,926.62 from the EOY Spending designated fund, \$50k from the Capital Improvements designated fund, \$100k from the WatersEdge line of credit, and \$11,073.38 from the Capital Improvements designated fund.
